RELEASE AND WAIVER OF LIABILITY AND INDEMNITY

In consideration of being permitted to participate in events associated with the Treasure Coast Jeep Club, Inc. (The "Club"), the undersigned for himself or herself, personal representatives, heirs, assigns and relatives, HEREBY RELEASES Treasure Coast Jeep Club, Inc., its members and officers, sponsors and all volunteers and their respective officers, directors, promoters, sponsors, employees, property owners, lessors and their agents, hereafter referred to as "Releasees" of any and all liability to the omission or Releasees or otherwise while the undersigned is for any purpose participating in any event of The Club. It is fully understood by each of the undersigned that there is some inherent risk associated with the event, including damage to vehicles and property, personal injury and/or death.

In addition, the undersigned AGREES TO INDEMNIFY AND HOLD HARMLESS the Releasees from any loss, liability, damage or cost they incur due to such participation by the undersigned, whether caused by the Releasee's negligence or otherwise and AGREES TO ASSUME FULL RESPONSIBILITY AND RISK for any bodily injury, death, vehicle or property damage from Releasee's acts, negligence or otherwise while the undersigned is participating in an event organized and/or sponsored by the above-named Releasees.

The undersigned acknowledges that all activities at an event are inherently dangerous, with the potential of death, serious injury and property loss. The risks include, but are not limited to, those caused by terrain, natural plant, insect and animal life, facilities, temperature, weather, equipment, vehicles, location, actions of other people (including but not limited to participants, volunteers, sponsors, event organizers, spectators, club officers and members) and failure to use proper safety equipment.

In signing this release, each of the undersigned hereby acknowledges and represents the following:

1. That he or she has read the foregoing Release and Waiver of Liability and Indemnity Agreement.
2. That he or she shall at all times, while riding in a vehicle participating in events of the day, wear respective seat and shoulder belts.
3. That the owner/driver is at all times while participating in an event in

compliance with all state and/or federal laws, including state auto insurance and driver's license requirements.

4. That the owner/driver agrees to assume full responsibility for his/her passengers in his/her vehicle and insures that all passengers have signed this release form.

5. The owner/driver has PIP and liability insurance on the vehicle as required by the state in which it is registered, and the owner/driver assumes full legal liability for any damage or injury which may be caused by the owner/driver's acts by negligence or otherwise.

6. That the owner/driver and all participants of an event acknowledge that participation in the event is purely voluntary and no one is forced to participate in spite of the risks.

For participants under 18 years of age, a parent or legal guardian must sign this release form and write the word "minor" and age next to the minor's name.
